IT IS ORDERED THAT:-

1. The Claimant has leave to enforce the LCIA Arbitration Award Number 101571 dated 10th January 2012 (the "Award") against the first and second defendants in the same manner as a Judgment or Order of this Court to the same effect and/or to enter Judgment against the first and second defendants in the terms of the said Award.
2. The first and second defendants do pay the Claimants' costs of this Arbitration Claim and of any Judgments which may be entered hereunder, such costs to be taxed if not agreed.
3. The Claimant has permission to serve this Order out of the jurisdiction upon the first Defendant personally at Villa No.10, 13 Mosil 2 Street, Burj, Dubai, United Arab Emirates, or wheresoever else he may be found and on the second Defendant at its registered office in Dubai, United Arab Emirates.

4. The Claimant has permission under CPR6.15 to serve this Order on the first Defendant by serving the same by post on the first Defendant's solicitors, Devonshires, at 30 Finsbury Circus, London, EC2M 7DT, using the reference of those solicitors when engaged in the arbitration to which this Order relates.
5. PROVIDED THAT within 22 days after service of this Order, the Defendants may apply to set it aside. Further, the Award and/or any Judgment entered pursuant to this Order shall not be enforced until after the expiry of that period or if either of the Defendants applies within that period to set aside the Order, then until after that application has been finally disposed of.
